• Concerts in the Park: The Board discussed a request from Alan Howe for the Village to commit to increasing its \$500 in support of the Concerts in the Park series. The Board felt that the current budget of \$3,000 could be committed. It was suggested that a possible \$200 increase might be supportable. No action was taken.

The topic was tabled until next month to give the Fire Department time to discuss the shorter period. Trustee Griffith moved to accept the dedication of Seward Street Extension. Trustee Whitenack made the second. Vote: Trustee Griffith. ave; Trustee LeBar, ave; Trustee Whitenack, ave; Trustee Kreiley, aye; Mayor Vogt, aye. Motion passed 5-0. • At 9:45 p.m. the Board unanimously agreed to continue the meeting.
