- Williams Park Living Welcome Sign: Steuben Landscaping submitted an estimate of a little over \$5,000. The best time to plant is April. The Board wants at least one more estimate per the purchasing procedures and would like to ensure other maintenance measures are remedied first. There is about \$15,000 remaining in the budget for park improvements.
