Village Clerk/Legislative: The following items were discussed:

#### Public Safety:

• Ambulance – President Jackson and Capt. Johnson provided their reports

Fire – Chief Horr provided his report. Of concern was the test failure of truck 518's ladder. Replacement parts difficult to find.
Code – CEO Malone provided her report. She noted that the Planning Board and ZBA will be holding public hearings. She also mentioned that Key Bank wants to build a handicap ramp similar to Teachouts'. Parking problems on Weidman Lane, Adams St. and at Babcock Park were discussed as well. Mayor Vogt raised the issue of a cat leash law.

• Police – Chief Perkins gave his report. Also discussed were the new officers' progress, DWI money, budget modifications, computer needs, and alarm system. The DCS Homecoming Night football halftime fireworks display was approved.

Courts – Justice reports were provided

Budget Finance & Audit: Monthly reports will be emailed tomorrow.

Public Works: Superintendent Tracy provided his report.

• Water and Sewer – The power feed line into the WWTP was shot and needed to be replaced. It should have been replaced during capital project. Board will consider adding to project cost. Also, sewer line on Quay St. will be scoped by Sewer Specialties, the Mills Corner water line replacement project is finished, the reservoir dam outfall is done. Additionally, Mr. Tracy noted that the coin-op water dispenser at the barns is providing trouble. The Board should consider replacing it and perhaps increasing the cost to users.

 Streets – Work on Austin St. continues. Superintendent Tracy also asked the Board to consider a pay increase for seasonal worker Brian Fairbrother. Street paving is still on the schedule and FEMA work on Mill Creek should start on Sept.
 15 and take about two weeks.

Parks and Rec: Mayor Vogt informed the Board that the next Parks, Rec. and Beautification Committee meeting will be at 6 p.m. on Sept. 22. There was also discussion about decorating stores for Christmas. The light poles are too fragile to place decorations other than light strings on them.

Technology

• Codification – Mayor Vogt asked that any changes to the General Code proposed table of contents be submitted to the clerk quickly as the deadline is fast approaching.

• Going Paperless – Trustee Rittenhouse emphasized the need to go paperless. Board consensus was in agreement.
