## **COMMITTEE REPORTS**

Village Clerk/Legislative: Mayor Vogt

- Motion by Trustee Whitenack and second by Trustee LeBar to approve the transfer of 142 Main Street from Sue Sylor to Rodney and Sandy Johnson. Board approval required because property is part of the Main Street Improvement Project. Vote: Trustee Whitenack, aye; Trustee LeBar, aye; Mayor Vogt, aye. Motion was unanimously approved (3-0).

- Mayor Vogt noted copy of Fire Department Babcock Park lease needs to be signed.
