Secondly, this neighbor is also concerned with the sidewalk on the East side of this project becoming an issue for him with mowing his grass. Mr. Bradley said the sidewalk on the East is critical to this project because it is a primary display side. As a solution to this issue, Mr. Bradley agreed to the top of the East sidewalk being installed at grass level. There was no further discussion.
